## 2014 Annual Report

As of September 4, 2014 we are officially non-profit 501 (c) 3. From the date Kingman's Healing Hooves was established in April 2010, we have been working as a "service" under the business A-Schuerr-Thing Horse Training LLC. Our original application date is also listed on the determination letter.

A-Schuerr-Thing Horse Training and Riding Lessons is a for-profit business and was accepting riders with Kingman's Healing Hooves (therapeutic riding lessons) at the facility initially under A-Schuerr-Thing Horse Training and Riding Lessons insurance policy umbrella. We have since retained our own insurance and leasing of horses from A-Schuerr-Thing Horse Training and Riding Lessons as agreement voted on and approved by the Kingman's Healing Hooves Board of Directors.

We are proud to announce we are growing with not only clients, also programs for all aspects of our community including:

- 1. Mohave County Probation—Diversion program for children 8-13 10 hours of community service and learning horsemanship
- 2. Mohave County Probation—JIP program including 14-18 with 40 hours of community service and learning horsemanship
- 3. Therapeutic programs for Veterans with physical disabilities
- 4. Therapeutic programs for those suffering from PTSD
- 5. Therapeutic programs for physical, emotional, and psychological disabilities and challenges ranging from 4 years old to 90
- 6. Outreach programs for schools and other organizations teaching horsemanship and therapy.

Additionally, we are looking forward to continued support from our volunteers, donors and community partners. The businesses and individuals who support KHH and our mission are critical to paying feed bills of therapy horses, travel expenses so we may serve our youth with our outreach programs in our community and travels throughout Mohave County, and therapy lessons at A-Schuerr-Thing Facility. We do not have staff on payroll as we are all volunteers as well, are goals are to progress with financial partners, so we will be able to incorporate salaries into our budget. As of now, all funds are used for educational products for lessons and care for the horses as they are the backbone of our program. Finally for those residents in our community who are not yet involved with KHH, we encourage you to come down and observe lessons to see if we are a fit for you as a volunteer and/or making a financial contribution to our organization.
